# 2. Overall Objective and Project Purpose

### 2.1 Overall Objective:

This project aims to contribute to the increased legal and social inclusion of the marginalised communities and facilitate their full enjoyment of citizenship rights in the Western Balkans.

## 2.2 Project purpose:

- To reduce the number of persons at risk of statelessness, which particularly affects the marginalised population, especially those displaced during the conflicts in the region;
- To facilitate access to free legal aid for the provision of personal documents as essential condition for marginalised groups to obtain and enjoy their basic citizenship rights;
- To increase awareness of marginalised groups and other relevant stakeholders of the need for civil registration and documentation as well as the need to remove unnecessary legal aid administrative obstacles associated with registration.

#### 2.3 Link with AP/NPAA / EP/ SAA

Human Rights and the Protection of Minorities is an issue mentioned in all the European / Accession Partnerships as a short-term or medium-term priority.

#### 2.4 Link with MIPD

This project has been designed on the basis of the Multi-beneficiary MIPD 2008-2010 in which social inclusion is a priority under Section 2.3.1.2.1 – Minority Rights, protection of minorities and refugee return. The objective to be achieved according to the Multi-beneficiary MIPD is to "ensure the protection of minorities and marginalised groups in accordance with EU and international standards in the sectors where the regional approach brings an added value (i.e. civil registration)."

### 2.5 Link with National Development Plan (where applicable)

The link with national programmes is appropriate as the civil registration of marginalised communities represents the first step of a process to assist these communities in sectors that are more relevant at national level. The provision of legal documents will enable marginalised groups to gain access to facilities such as medical insurance, school attendance, employment and civil rights. In this regard, when the regional activities have been completed (civil registration), activities of a national scope will take over and enable marginalised communities to participate in sectors such as education, health care and labour market.

#### 3. Description of project

#### 3.1 Background and justification:

The conflicts associated with the break-up of former Socialist Federal Republic of Yugoslavia (SFRY) have caused suffering and displacement for large numbers of people, including ethnic minorities. For the Roma, Ashkali and Egyptian (RAE) communities, displacement has caused a further deterioration of their access to basic human rights, aggravating their already significant levels of poverty and social exclusion. The marginalised communities in the

Western Balkans are particularly vulnerable due to generally low levels of education, lack of personal documents, deep-rooted and institutionalised discrimination, and limited access to the full enjoyment of their civil, political, social, economic and cultural rights. The current situation of the marginalised communities represents a serious human rights and human security problem in the region. The Western Balkans must work towards the social inclusion of these minorities to comply with their responsibilities under the European Social Charter, as well as fulfilling the requirements of EU accession.

One of the fundamental disadvantages for the marginalised groups in the Western Balkans is their lack of personal documents and/or civil registration. These are essential for them to prove or acquire nationality and to enjoy equal access to citizenship rights. The lack of personal documents and/or civil registration represents an obstacle to their integration into existing communities. For example, children are denied school registration, and access to employment as well as to social services is blocked.

This leads to a parallel world of people outside the system without access to basic rights. The absence of one document frequently leads to a "chain reaction" where individuals are unable to secure further documents. The movements during the various conflicts in the Balkans exacerbated this problem as existing documents were lost or destroyed, fragile links with communities of origin were severed and families were separated. Because of their marginalisation, RAE themselves have often not been fully aware of the importance of civil registration, naturalisation and documentation to enable them to gain full access to basic civil, political, social and economic rights. At the same time, the authorities often lack understanding and sensitivity as to the extent and possible consequences of this problem, and the concrete need to address it.

3.2 Assessment of project impact, catalytic effect, sustainability and cross border impact (where applicable)

As this programme represents the second phase of a previous operation, it is foreseen to take into consideration the impact of the 1<sup>st</sup> phase in the drafting and the preparation of the project. A project impact assessment will be undertaken at the end of the ongoing project.

The cross border impact is present through the possibility for the authorities and the contractor to coordinate and avoid the duplication of the delivery of documents.

#### 3.3 Results and measurable indicators:

- 1. Expanded awareness and pro-activity of local authorities in civil registration and provision of documents to marginalised communities;
- 2. Increased registered persons in the municipalities of the Western Balkans from the marginalised groups;
- 3. Increased access to school, medical insurance, employment and civil rights for the marginalised communities.

#### 3.4 Activities:

1. Raising awareness of marginalised communities in the civil registration and naturalisation process through electronic and printed media;

- 2. Raising awareness and increasing pro-activity of authorities at all levels in civil registration and access to documents through round tables, seminars and meetings;
- 3. Increasing capacity of stakeholders through training, workshops, marginalised community participation, consultants and by provision of technical support;
- 4. Advocacy with authorities and legislative bodies for improvements in procedures and services linked to civil registration;
- 5. Free legal aid in provision of documentation;
- 6. Facilitate exchange of information and documentation between competent state authorities of the Beneficiaries involved in order to ease registration.

#### 3.5 Conditionality and sequencing:

- Cooperation and commitment of relevant authorities in the region at all levels and active participation of marginalised communities;
- Willingness of relevant authorities to implement necessary changes and alleviate position of marginalised groups.

#### 3.6 Linked activities

The proposed activities have been designed to take into consideration the regional aspect of the issue. Civil registration is linked to other matters that have to be addressed at the national level. Projects relating to education and housing complement the regional programme. The present programme should be seen as a pre-condition for marginalised groups to legally become the beneficiaries of other projects of a national nature.

Apart from the support to marginalised communities, the Commission has also been active in refugee return. In parallel to the physical return, assistance has also focused on providing lasting solutions to the refugees and Internally Displaced Persons who wish to remain in their host country. Therefore, similar activities to those of the present Programme have been delivered to the target population, such as provision of legal assistance.

#### 3.7 Lessons learned

This programme represents the second phase of a current project undertaken by UNHCR. Considering the needs and the regions to be covered, a follow-up project is necessary. The preparation of the project will take into account all the lessons learned from the previous operation. As the original project started in February 2008, there are no details on the lessons learned as yet. A project impact study will be requested of the contractor in the course of the implementation of this project.
