Strengthening the Kosovo Assembly

An effective parliament is a cornerstone of a stable democracy, and for the Kosovo Assembly to fulfil its tasks properly, it needs a professional and effective civil service. This is why the EU funded a twinning programme to boost the capacity of the Assembly's administration. This not only increased skill levels, but also put the Assembly in a better position to align the country with EU rules and best practices.

CLOSER LINKS WITH CIVIL SOCIETY

The project was implemented by the Hungarian National Assembly with the involvement of more than 70 experts from ten EU Member States, working with their colleagues from Kosovo on improving the legislative and oversight capacities of the Assembly, including the role of committees, Assembly Presidency and the EU law approximation process. The results were stronger financial management and better use of staff, a smarter document management system, closer links with civil society, and improved organisation of international and interparliamentary activities.

In particular, the project raised the profile of the Assembly's Committee on European Integration, supported the foundation and development of the research services, and widened awareness of staff and members of the Assembly on issues relating to the EU.

IMPROVED SKILLS IN DRAFTING LEGISLATION

Technical skills are required to scrutinise and to draft legislation in line with EU norms, to monitor implementation after adoption and to prepare the country for the different phases of EU integration. Efforts to establish a professional and accountable administration in the Kosovo Assembly, free from undue political interference, are important steps towards creating a legislative organ that operates on the basis of evidence and the needs and wishes of the electorate. This is a way to advance the standard of living of Kosovo's citizens and to support progress towards European integration.
