## 1. Basic Information

### 2. Description

On the basis of Association Council decisions and Agreements, candidate countries may participate in certain European Community programmes and agencies.

The Phare programme can be used to help a candidate country to meet part of the costs of participating in those programmes and agencies. A maximum of 10% of the Phare national programme may be used to co-finance participation in Community programmes and agencies other than the Research and Development framework programme. Participation in the R&D programme does not count towards the10% limit.

As from 2001, these funds will be made available each year as part of the Phare national programme so as to co-finance the financial contribution to be paid by the country to participate in these programmes and agencies in the following year. This project fiche for the Phare national programme accordingly shows Phare co-financing for Romania's participation in Community programmes and agencies in 2002 with one exception. An allocation for the SAVE programme is made also for participation in 2001, with the condition that Romania pays as a minimum the administrative costs of this participation in 2001.

#### 4. Implementation Arrangements

4.1 The National Fund is responsible for the Phare part of the financial contribution to be paid by the country to participate in Community programmes and agencies.

4.2 Upon signature of the Financing Memorandum the National Fund will request from the Commission the transfer of the full amount of the Phare Support indicated in section 3 above. These funds must be used to pay the Phare part of the financial contribution to be paid by Romania to participate in Community programmes and agencies.

4.3 The various Commission services responsible for the different programmes or agencies will send to the Mission of Romania to the EU a request for the total financial contribution to participation in a given programme or agency ("call for funds"). The National Fund should check the amount to be financed from Phare funds and then
