IBU missions in the Western Balkans

In order to present directly to all local Twinning stakeholders the changes brought about by the entry into force of the new Financial Regulation in 2013, Paolo Gozzi carried out missions to Pristina, Skopje and Sarajevo at the end of November 2013 and to Tirana in January 2014. These missions were a good opportunity to discuss also the new flexibility introduced in Twinning procedures and to have an open and useful dialogue with colleagues, Resident Twinning Advisers (RTAs) and local officials. On the occasion of his presence in Pristina, Paolo intervened at the closing ceremony of a Twinning project implemented by Italy and France for the benefit of the Ministry of Environment.

RTAs training and possibility for the beneficiary country project leaders (BC PL) to attend

The 52nd Basic Training course for Resident Twinning Advisers is planned for 6 and 7 March 2014. If the opportunity to attend (at their own costs) had already been offered to MS PL, for the first time now also BC Project Leaders will be able to attend the training, together with the Member State (MS) RTA of the same project. Costs for travel and per diems can be financed by the budget of the project as for the MS RTA. Attendance of the BC PL cannot be deputised to a third person, except the BC RTA Counterpart. The choice of the participant (BC PL or BC RTA Counterpart) should take into consideration the fact that the whole training is given in English and whoever is not fluent in that language should refrain from attending.

Participation of the BC PL or of the BC RTA Counterpart must be agreed with the Lead MS Project Leader, who will be responsible for the logistical arrangements of such participation and will include the corresponding costs in the budget according to the same provisions applicable to the MS RTA.

The participation of BC PL (or RTA Counterpart) can be budgeted only in Twinning contracts for which the Project Fiche has been circulated after 1 January 2013.

Some 25 participants are expected to participate to Training programed for March 2014 in Brussels.

Mandated Bodies Review 2013 and future approach

Following the periodic update of the list of Mandated Bodies carried out in 2013 with the fundamental support of MS National Contact Points, some adaptations to the principles governing the contribution of Mandated Body (MB) to the implementation of Twinning projects will be introduced in a new revision of the Manual. The purpose of these adaptations is to reinforce the sectorial specialisation of MB contributing to Twinning. In particular, this will imply that the sector or sectors in which a MB is authorised to contribute to the implementation of a Twinning Project are going to be specified in the list of MB published by the Commission.

Anticipating the introduction of these provisions in the Manual, as of January 2014 the attribution of Mandated Body status will be associated with the indication of the sector of competence.

More and more Twinning Review Missions (TRM)

The preparation for the regular implementation of Twinning Review Missions foreseen for Projects under the 2009 and 2012 Manuals is now reaching cruising speed. After the first TRM took place in Turkey in December 2010, more than 10 TRM took place already, namely for projects:

Good Practices: Twinning Fiches – Experience required for RTAs and ST experts and Description of Activities

* This designation is without prejudice to positions on status, and is in line with UNSCR 1244 and the ICJ Opinion on the Kosovo Declaration of Independence.

Twinning fiches submitted to Brussels HQ for circulation to MS sometimes contain experience requirements for the RTA and the short-term (ST) experts which appear to be highly ambitious. While proven competence and experience of the RTA and of key STE are fundamental for the successful implementation of a project, setting the bar very high can be counterproductive. On the one side MS could find difficult to identify suitable candidates, with the consequence that the call receives only a limited number of proposals. On the other, the risk could materialise of a "professionalization" of RTA, which is something that the Commission wants to avoid.

When drafting Twinning Fiches, it is important to pay due attention to this aspect and properly evaluate what can be considered reasonable experience. The Twinning Manual 2012 provides guidance on this issue, under section 2.2.2 - Qualification of RTAs "To qualify for secondment, RTAs must have at least three years' experience in activities related to the implementation of the EU acquis in the area covered by the Twinning project fiche, to the pertinent legislative process or to other actions referred to by the Twinning project fiche covering their secondment."

Also, in line with the Twinning Manual 2012, Twinning fiches do not need to list all activities in detail; it is more important to thoroughly define Mandatory results. This shall reduce length and simplify Twinning fiches while giving more freedom to MS' in preparing original proposals with specific methodologies. In turn, it would probably result in an increased differentiation amongst written proposals for which the most common criticism is that they are often a "copy paste" of the Twinning fiche and hence result in better quality.
