THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012¹ and in particular Article 110 thereof,

Having regard to Regulation (EU) No 2021/1529 of the European Parliament and of the Council of 15 September 2021 establishing the Instrument for Pre-Accession Assistance (IPA III)² and in particular Article 19 thereof,

Whereas:

- (1) The Commission adopted the Annual Action Programme for Bosnia and Herzegovina for the year 2020 by Commission Implementing Decision C(2020)432 of 17 February 2020, further amended by Commission Implementing Decision C(2020)5281 of 28 July 2020.
- (2) In order to ensure the effective contracting and use of IPA 2020 funds, it is necessary to amend the action “EU4 Home Affairs” with the objective to allow for implementation through indirect management. Therefore, Decision C(2020)432 final should be amended accordingly.
- (3) The proposed assistance is to comply with the conditions and procedures set out by the restrictive measures adopted pursuant to Article 215 TFEU.
- (4) The measures provided for in this Decision do not fall into the categories of measures for which the opinion of the IPA III Committee is required. The measures will be communicated to the European Parliament and to the Member States through the IPA III Committee within one month of its adoption.

HAS DECIDED AS FOLLOWS:

Article 1

Annex I to Commission Implementing Decision C(2020)432 final is replaced by the Annex to this Decision.
