## **Changes in the Twinning and SIGMA Coordination Team**

*After eight years of dedicated work to Twinning, Alain Van Hamme will leave the Team by the end of this month. On 1 September he will start working in the Ministry for Foreign Affairs in Paris, participating in the Diplomatic Exchange and Second Programme (DESP), an exchange programme between the European institutions and the Member States in the framework of the future European external action service. Alain followed the Twinning instrument almost from its infancy and helped it grow up: he saw the launch of more than 1000 classical Twinning projects in the Enlargement context, sharing experience and promoting the instrument as effective European added value; he handled the successful finalisation of the Twinning experiences in the 10 new Member States and the launch and rapid expansion of Twinning in Turkey and the Western Balkans. ## Importance of complete CVs in Twinning proposals *Good Practice*

It happens regularly that during Twinning evaluations the beneficiaries and the Contracting Authority find CVs which do not contain the minimum information requested in the Twinning fiche. This can be the level of knowledge the requested working language, the computer skills, the job descriptions, the dates during which a specific position was held. In these cases clarification has to be obtained from the Member States. This is slowing down the evaluation process.

We recommend therefore that the Member State NCP checks before they submit a Twinning proposal that the CVs enclosed contain the minimum information required.

### Create an Intranet Site for your project

*Good practice from Bulgaria*

Project BG 07 IB JH 02 UE TWL, "Strengthening the Administrative Capacity of the Public Prosecutor's Office for fighting organized crime in the sphere of cultural goods in particular and related applicable EU acquis"

*Italy is recognized as one of the world leaders in combating the illegal traffic of cultural artefacts,*

thanks to the close cooperation between a specialised pool of magistrates, the Ministry of Cultural Heritage (MIBAC), and a unit of the Carabinieri which responds directly to the MIBAC and specialises in fighting this kind of crime. The key expert is Paolo Giorgio Ferri, who has a wide reputation, and who is able, thanks to the Twinning project, to dedicate a total of 22 working days to providing assistance to the Bulgarian Prosecutor's Office in combating cultural crime.

The European dimension of the project lies in the fact that the overall objective is the improvement of the Bulgarian authorities' capacity to implement a series of European regulations and directives (especially Council Regulations 3911/92 – amended by the Council Regulation n. 2008/116- and Directive n. 7/93).

The Italian experts have adopted a practical approach in this project, proceeding inductively from hypothetical test cases to an analysis of the effectiveness of Bulgarian legislation. Three specific cases of cultural crime were presented, and the Bulgarian experts were asked to reflect on the charges that might be brought and the investigative means that might be used in these cases. These cases were presented via the project intranet well in advance of the missions of the experts, so that written responses could be submitted and analysed before the experts even reached Bulgaria. In this way the effectiveness of the face-to-face sessions was maximised, and the issues at stake were clarified thanks to the direct and concrete nature of the examples.

Formez, a Member State partner, has provided the project with an Intranet site which allows experts and project managers to keep track of documents and activity schedules easily and simply, wherever they are. The website, based on Moodle open-source software, functions as a document archive, as a management tool and as a social fora. As an archive, the site stores project documents, legislative texts (Italian and Bulgarian norms, international conventions etc) and other background material. It also provides links to relevant websites. The site also provides a calendar and a set of management tools for planning, administration, and financial monitoring and reporting. Furthermore, it offers a number of forums for discussion and exchange among enrolled participants.
