# COMMISSION IMPLEMENTING DECISION

## **amending Implementing Decision C(2025)2225 final as regards increasing the Union contribution for the financing of the Ukraine Facility Pillar III for 2025 (Part 3)**

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2024/2509 of the European Parliament and of the Council of 23 September 2024 on the financial rules applicable to the general budget of the Union<sup>1</sup>, and in particular Article 110 thereof,

Having regard to Regulation (EU) 2024/792 of the European Parliament and of the Council of 29 February 2024 establishing the Ukraine Facility<sup>2</sup>, and in particular Article 38 thereof

Whereas:

- (1) On 16 April 2025, the Commission adopted Commission Implementing Decision C(2025)2225 final<sup>3</sup> on the financing of the annual work programme of Pillar III under the Ukraine Facility for 2025 (part 3), including two actions.
- (2) It is necessary to amend the action “Technical Cooperation Facility for Ukraine 2025”, in Annex I to Commission Implementing Decision C(2025)2225 final, to increase the budget of that action by EUR 234 031 586.59, allocated to Union programmes benefiting Ukraine by Council Decision (CFSP) 2024/1470<sup>4</sup> and to the Ukraine Facility by Council Regulation (EU) 2024/1469<sup>56</sup> in accordance with Article 7 of Regulation (EU) 2024/792.
- (3) The amendment aims at further enhancing the objectives of the action supporting Ukraine’s progressive alignment to the Union acquis as well as the implementation of the Ukraine Plan, while strengthening the country’s resilience and capacity to respond to the impacts generated by Russia’s war of aggression.
- (4) Therefore, Decision C(2025)2225 final should be amended accordingly.

A transfer agreement with the Kingdom of Sweden will be signed after the adoption of this Commission Decision.

- (5) The proposed assistance is to comply with the conditions and procedures set out by the restrictive measures<sup>7</sup> adopted pursuant to Article 215 TFEU.
- (6) The measures provided for in this Decision are in accordance with the opinion of the Ukraine Facility Committee established under Article 42 of Regulation (EU) 2024/792.

HAS DECIDED AS FOLLOWS:

#### Sole Article

Commission Implementing Decision C(2025)2225 final is amended as follows:

Article 2 is replaced by the following:

#### “Article 2

The maximum Union contribution for the implementation of the work programme for 2025 is set at EUR 389 031 586.59, and shall be financed from the appropriations entered in budget line 16 06 03 01 of the general budget of the Union.

The amount referred to in the first paragraph shall include contributions from the Kingdom of Sweden to the general budget of the European Union as external assigned revenue as provided for in Annex I.

The appropriations provided for in the first paragraph may also cover interest due for late payment.

Annex I is replaced by the Annex to this Decision.”
